THE FLAME NIGHTCLUB HELD A BENEFIT FOR THE ALANO CLUB ON MARCH
13, AND NETTED THE ALANO CLUB \$150.00

ON APRIL 13, 1991 FROM 10:00 A.M. TO NOON, THERE WILL BE A PANEL,
HOSTED BY STEPPING STONE AS PART OF ITS SECOND SATURDAY SERIES,
ON THE EFFECTS, BENEFITS, AND RAMIFICATIONS OF THE HUMAN DIGNITY
ORDINANCE IN SAN DIEGO. IF YOU ARE INTERESTED IN THIS VERY VITAL
ISSUE, THEN PLAN TO ATTEND.

SMOKING-NONSMOKING VOTE. THE RESULTS OF THE VOTE ON MAKING THE
CLUB A NONSMOKING PLACE WERE AS FOLLOWS: 74 IN FAVOR OF NO SMOK-
ING; 71 AGAINST MAKING THE CLUB NON-SMOKING. THE BOARD OF DIREC-
TORS WILL ACT ON THESE RESULTS; HOWEVER, IT IS APPARENT THAT THE
CLOSE VOTE INDICATES THERE IS NOT A CLEAR CUT MANDATE TO EFFECT A
CHANGE. THE BOARD APPEALS TO THOSE WHO ARE SMOKERS TO COME UP
WITH A SOLUTION TO ADDRESS THIS PROBLEM.

AT THE LAST REGULARLY SCHEDULED MEETING OF THE BOARD OF DIREC-
TORS, THE BOARD VOTED TO RAISE MEMBERSHIP DUES EFFECTIVE JULY 1,
1991. THE NEW SCHEDULE OF DUES IS AS FOLLOWS:

- MONTHLY: 12.00 SINGLE; 18.00 FAMILY
- SEMI-ANNUAL: 60.00
- ANNUAL: 120.00
- SENIOR CITIZENS (55 AND OLDER)
- MONTHLY: 6.00; SEMI-ANNUALLY: 30.00
- ANNUALLY: 60.00

THIS IS THE FIRST RAISE IN DUES SINCE THE CLUB'S INCEPTION, AND
WILL HELP DEFRAY THE COSTS OF THE RAISE IN RENT OF \$400. PER
MONTH.
